The Management has submitted the proposals for grant of permission to open classes from I to VIII English Medium (without aid) during the academic year 2023-2024 - in respect of Silver Bells Central School, Karakambadi Village, Renigunta Mandal, Tirupathi District to this office in the reference 8<sup>th</sup> read above.

The District Educational Officer, Tirupathi District has verified the application for grant of permission to open classes from I to VIII English Medium (without aid) during the academic year 2023-2024 (without aid) with reference to the report of the Mandal Educational Officer, Renigunta, Renigunta Mandal, Tirupathi District and also with reference to the condition laid down in the G.O.Ms.No.1., Edn., dated: 01.01.1994.

After careful examination of the references cited and conditions prescribed in G.O.Ms.No.1 Edn., dated: 01.01.1994 and its amendments the District Educational Officer, Tirupathi District is hereby accorded for Grant of permission to open classes from I to VIII English Medium (without aid) during the academic year 2023-2024 (without aid) in respect of Silver Bells Central School, Karakambadi Village, Renigunta Mandal, Tirupathi District with the following conditions.

- 1) That the society shall abide by the instructions / rules and regulations made by the Government, authorized officer from time to time.
- 2) That the Educational Institution shall serve the needs of the locality more particularly.
- 3) That the institution shall adopt the curriculum and syllabus prescribed from time to time.
- 4) The school timings vacations and mid-term holidays shall be as prescribed by the Govt. from time to time.
- 5) That the qualified staff within the age limits prescribed by the Govt: for Govt. employees shall be appointed as per the staff pattern.
- 6) That the results of the institution shall be satisfactory every year.
- 7) That the records / accounts shall be furnished to the District Educational Officer (or) Nominee every year by July at the latest.
- 8) That the list of Governing body shall be furnished to the District Educational Officer / competent authority every year.
- 9) That the pay structure / fee structure fixed by the Governing body shall be get approved by the District Educational Officer (or) his Nominee every year.

- 10) That all the conditions prescribed in the G.Os and other orders which are not specified in these orders shall be complied with otherwise the recognition will be cancelled.
- 11) That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 6 months before.
- 12) That the school shall be closed or permitted to be closed only from date on which summer vacation is declared.
- 13) That the society shall be submit proposals for extension of temporary recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the recognition (as per G.O.MS. No. 01 Edn., dated: 01.01.1994).
- 14) Only single section in each class is recognized.
- 15) The management should follow the rules and regulations prescribed in circular Memo. No. 21748/D1/1997, Dated: 16.02.1998 and other orders of transport authorities regarding maintenance of school vehicles / maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport authorities as prescribed by the Govt. from time to time.
- 16) The management should have adequate personal guide, the movement of the children to ensure the road safety and transportation.
- 17) The Management should adhere the instructions issued by the District Educational Officer, Tirupati from time to time.
- 18) The Management should take on lease and registered in the name of society for play ground immediately without fail.
- 19) The above extension of temporary recognition is subject to a written undertaking being given by the school Management that the recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre-requisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfill any prerequisite as stipulated, the Recognition now being is liable to be withdrawn at once.
- 20) The management is requested to fulfill all the conditions stipulated in G.O's read above.
- 21) The Management should submit fire certificate from the concerned fire officer / authority within **one Month** without fail. If not submitted the recognition will be cancelled without any further notice.
- 22) The management should follow the provisions of RTE Act.

The receipt of these proceedings should be acknowledged.
